Product is intended to provide residual control of human coronaviruses, including SARS-CoV-2 on non-porous treated surfaces. *SurfaceWise*<sup>®2</sup> is a continuously active, antiviral coating that kills 99.9% of viruses, including SARS-CoV-2, within 2 hours. For continued protection, *SurfaceWise*<sup>®2</sup> may be reapplied as frequently as every 7-days. This continuous protection interval may be extended with approval by the US Environmental Protection Agency, as additional efficacy and durability data are developed. This product is intended to supplement, not replace, routine cleaning and disinfecting protocols to provide protection in between cleaning and disinfecting regimens.

Prior to application of *SurfaceWise*<sup>®2</sup>, the surface must be pre-cleaned/disinfected using a one-step EPA registered disinfecting cleaner listed under List N: Disinfectants for use against SARS-CoV-2, <https://www.epa.gov/pesticide-registration/list-n-disinfectants-use-against-sars-cov-2>. Follow all applicable label use instructions on those products.

**DO NOT DILUTE *SurfaceWise*<sup>®2</sup>.** Apply *SurfaceWise*<sup>®2</sup> immediately following pre-cleaning & disinfecting by approved List N disinfectant/cleaners, after surfaces have dried. Areas to be treated should be unoccupied by individuals other than the applicators, while treatment is occurring. *SurfaceWise*<sup>®2</sup> must be applied by electrostatic sprayer, setting the flowrate to approximately 1 gallon of product/hour. Application at this rate will cover approximately 3,200 ft<sup>2</sup>/hr. Spray surfaces from a distance of 24-36 inches to the point of saturation being careful not to let the liquid start to drip. Apply to all surfaces paying particular attention to the underside of surfaces. A sheen will be present on the surface following treatment. Following application, allow treated surfaces to completely air-dry (approximately 10 minutes) prior to handling. Aircraft and airline facilities may be reentered following drying.

To maintain protective effect on surfaces that have been treated with *SurfaceWise*<sup>®2</sup>: alcohol-based disinfectants and cleaners should not be used and treated surfaces should not be subjected to moisture for prolonged periods of time.

**Personal Protective Equipment:** Applicators must wear long pants, socks and shoes, long sleeved shirts, chemical resistant gloves, and NIOSH approved N-95 or KN-95 respirators.

**Storage and Disposal:** Do not contaminate water, food, or feed by storage or disposal.
